General Guidelines

- All trash and recyclables must be disposed of in the proper receptacles. Groups are expected to do a general pickup of areas used before they depart.
- **We are a non-smoking facility.** If members of your group require accommodations, they will be directed to their cars in the parking lot. **Smoking is PROHIBITED!**
- The waterfront area will be open for a time period agreed upon when your contract takes effect. We reserve the right to limit water activities based on weather conditions. Use of the area is **only permitted** with a YMCA Camp Lincoln lifeguard present.
- Groups have access to those facilities agreed upon by contract. All additional activities planned by your group must be approved by a YMCA Camp Lincoln Director.
- YMCA Camp Lincoln will have a rental coordinator available on the grounds on the day of your event to address any questions, concerns or emergencies.
- The contact person or designee must be the first one to arrive and check-in with the Rental Coordinator. A walk through will take place and a written list of noted damages or concerns will be created. At the end of the program the contact person or designee will walk the property with the Rental Coordinator and look for damages, concerns or excessive cleaning concerns. Rental groups will be responsible for all fees.
